As directed, Technical & Price Bid, Tender invited by the Directorate of A.H & Veterinary, Meghalaya vide No. MVD/SCH-I(MA)2009-10/37, dt. 4.6.09, for providing Consultancy for updating of Detailed Project Report and Preparation of Tender Document and other essential reports for the Construction of Modern Abattoir at the selected site at Shillong is hereby retendered, as the rate quoted by the two Tenderers are too high. The Directorate of A.H & Veterinary invites substantially responsive bids from qualified, experienced, professional abattoir consultants for preparation of tender document on a Turn Key Basis.

SCOPE OF WORK:

1. Preparation of Tender Document to select a suitable bidder for construction of modern mechanized, Multi-species Abattoir with a capacity for handling 240 heads of cattle, 240 pigs and 160 sheep & goats per day.
2. Designing the Abattoir for the proposed capacity that includes defining the project components, design of the layouts, drawings, quantity estimates and cost estimates of buildings, machineries and equipments.
3. Assisting the Directorate to prepare the tender documents and other essential reports.

ELIGIBILITY CRITERIA:

1. Consultant should be firm/key personnel who have designed/carried out at least one project of mechanized slaughter facility for any Corporation/Municipality.
2. Consultant should have design at least one project of Modern Slaughter facility in the past five years.
