7. Period of Validity of Bids:

- i. Validity of Bids shall be 18 months after the date of bid opening. A bid valid for a shorter period shall be rejected by the DIRECTOR, DEPARTMENT OF ANIMAL HUSBANDRY & VETERINARY as non-responsive.
- ii. In exceptional circumstances, the DIRECTOR, DEPARTMENT OF ANIMAL HUSBANDRY & VETERINARY may solicit the Bidder's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. The Earnest Money provided shall also be suitably extended. A Bidder may refuse the request without forfeiting its Earnest Money. A Bidder granting the request will not be permitted to modify its bid condition.

8. Earnest Money Deposit (EMD):

- i. The Bidder shall furnish, as a part of its bid, Earnest Money of Rs.2,75,000/- for non-tribal bidder & Rs. 1,37,500/- in case of tribal bidder.
- ii. The Earnest Money is required to protect the DIRECTOR, DEPARTMENT OF ANIMAL HUSBANDRY & VETERINARY against the risk of Bidder's conduct, which would warrant the security's forfeiture.
